

Victorian Energy Efficiency Certificate (VEEC) Assignment Form

Gas Water Heater, or Solar or Heat Pump Water Heater Installation in a Business or Non-Residential Premises

VEECs can only be created for an installation REPLACING an Electric or Gas Water Heater in an EXISTING premises.



1. CONSUMER RIGHTS INFORMATION

As the energy consumer, you own the rights to create Certificates for energy saving activities undertaken at your premises under the Victorian Energy Upgrades program. One Certificate represents one tonne of carbon dioxide equivalent (CO₂-e) to be reduced by the activity.

You are able to assign your right to create Certificates to an accredited provider of your choice under the Victorian Energy Upgrades program in exchange for a financial benefit. In assigning your right, the accredited provider will be entitled to create and own the Certificates for the activity undertaken at your premises, and provide you with a financial benefit (e.g. price reduction on a product, free installation or a cash-back arrangement). Rheem Australia Pty Ltd ABN 21 098 823 511 (hereafter referred to as Rheem) is an accredited provider. You are not obliged to assign your right to create VEECs to Rheem.

If you choose to assign your right to create Certificates to Rheem, you will receive the financial benefit either by Point of Sale Discount or after the VEECs have been created. You are responsible for ensuring you are satisfied with the terms of the assignment of Certificates to Rheem (as detailed below) prior to proceeding with the activity. The value of a VEEC will change depending on market supply and demand. Rheem will pay our current rate on the day we receive the form. To find out the current value of VEECs you can call us on 132 552. To allow sufficient processing time, all claims must be received by 30th April in the year after installation.

If you experience any issues with the outcome of this activity, you should contact the Rheem VEECs Department to resolve the matter. - Copy of the recycling invoices** (where applicable)
- Geo-tagged photo(s) showing:**
 - the existing water heater before the upgrade (to demonstrate eligibility)
 - the decommissioned water heater rendered permanently inoperable
 - the brand, model and serial number of the decommissioned water heater
 - the installed water heater after installation
 - the brand, model and serial number of the installed water heater
- An Invoice for the VEECs financial benefit** (only if the payment is to be made to a business)
The invoice should be made out to Rheem Australia Pty Ltd and must show your ABN. If you are charging GST this should be a tax invoice.
